Parental Waiver

Understanding of Liability

By participating in Wonder Seekers Sensory Play activities, you and your child willingly accept the associated risks, including potential injury or property damage. You agree to absolve us, Wonder Seekers Sensory Play, of any liability or claims related to your child's participation, unless due to our negligent or wrongful conduct.

I understand that as a parent or guardian, I will not hold Wonder Seekers Sensory Play or its employees accountable for any injuries or damages my child might experience during the play sessions.

Acknowledgement of Risk

I acknowledge that activities may be 'messy' and could cause staining or damage to clothing, shoes, or personal belongings, and that Wonder Seekers Sensory Play is not liable for such issues.

I acknowledge and understand the inherent risks associated with the activities at Wonder Seekers Sensory Play, including potential exposure to allergens, slips, falls, and minor injuries. I voluntarily agree to assume all of these risks for my child.

Supervision & Safety

As a parent/guardian, I am wholly responsible for my child/ren during the sessions and events – remember, Wonder Seekers Sensory Play is not a daycare or baby sitting service; it is my responsibility to actively supervise my child at all times during the play sessions and accept full responsibility for their safety.

I agree to monitor my child/children while interacting with all materials, both provided by Wonder Seekers Sensory Play and those found in the general environment. I understand these materials may pose potential choking hazards, allergic reactions, or other harm if not supervised appropriately.

The Wonder Seekers Sensory Play staff is not responsible for providing personal care, including feeding, changing, or administering medication to my child.

Each station/ activity is designed to serve a certain number of children. If the station is at capacity, children should be guided by their parent to play elsewhere until it becomes available. This is to ensure everyone enjoys their time safely and fairly.

I understand that materials, resources, and tools must be used in the manner in which they are intended e.g. spoons to be used as spoons, not hammers.

Behaviour Management

I understand that Wonder Seekers Sensory Play reserves the right to dismiss any participant who exhibits behaviour that could pose a threat to the safety or wellbeing of others.

Child's Condition Disclosure

I agree to inform Wonder Seekers Sensory Play in writing of any physical, emotional, or behavioural conditions that my child may have which could affect their participation in the activities.

Awareness of Health and Illness

I acknowledge that if my child is ill or has a contagious condition, it is my responsibility not to bring them to a session.

Allergy Awareness & Medication

I acknowledge my responsibility to inform Wonder Seekers Sensory Play of any allergies my child may have.

I understand that although Wonder Seekers Sensory Play strives to avoid allergens, a completely allergen-free environment cannot be guaranteed due to the use of various food bases in sensory experiences.

I agree to bring any necessary allergy medication for my child, releasing Wonder Seekers Sensory Play from any responsibility for allergic reactions resulting from the activities.
